



Grant Information

1. Introduction

Recreation and parks opportunities are an integral part of the health and quality of life of Saskatchewan residents. The Saskatchewan Parks and Recreation Association's (SPRA's) *June is Recreation & Parks Month* (JRPM) *Celebration Initiative Grant* provides a foundation from which to launch activities, to increase awareness of the benefits of participation in recreational activities and to have access to parks and open spaces. Increasing citizen participation is one of the best ways that health care costs can be reduced and social cohesion can be enhanced. Participation encompasses play, fitness, sports and outdoor activities such as gardening, walking, biking, arts and cultural pursuits. Involvement assists individuals to develop and maintain social, emotional and physical well-being.

2. Purpose

SPRA would like to acknowledge the continued impact that the JRPM – *Celebration Initiative Grant* has on the recreation and parks services in Saskatchewan. In 2017, SPRA is pleased to have the opportunity to offer financial assistance to JRPM Ambassadors, through supporting communities and agencies that are Active members of SPRA. Through this funding program, SPRA is able to:

- Support localized promotion of the sector's benefits
- Ensure that June will be recognized as June is Recreation & Parks Month
- Support planned events or programs

3. Funds Available

SPRA Active members that are registered in the JRPM Ambassador program, and plan to deliver a community wide event, can apply for the funding. SPRA will contribute a maximum of \$500 per Active member. Only one grant per eligible applicant will be processed and funds for retroactive expenses will not be approved. Funding will only be distributed to the Active member, as payment will not be issued to individuals.

4. Eligibility

- Active members of SPRA are eligible to apply
- Communities that have outstanding follow-up reports for other SPRA grants are not eligible
- Communities that are registered as a JRPM Ambassador and conduct an event that runs between June 1 to June 30, 2017 are eligible

5. Funding Obligations

All funds must be used by June 30, 2017. All follow-up material must be submitted by Friday, August 11, 2017.

Where possible, groups receiving grants must publicly acknowledge Saskatchewan Lotteries and the Saskatchewan Parks and Recreation Association within their events. Funds granted through the SPRA JRPM *Celebration Initiative Grant* may only be used for the purpose stated in the application. Funds are not transferable and SPRA must approve, in writing, any significant change in the use of funds. **Funds that were spent incorrectly will not be reimbursed by SPRA**.

Grants will not be approved if an applicant has any outstanding grant follow-ups with the Saskatchewan Lotteries Community Grant Program, SPRA or the Saskatchewan Lotteries Trust Fund.

Failure to meet the above funding obligations to the satisfaction of SPRA will be grounds to withhold payment and restrict access to future funding.

6. Application Process

Applications will be accepted from May 11, 2017 to June 15, 2017. Applications will be processed on a first come, first served basis. The Celebration Initiative Grant funding is capped and once the funds are allocated, the Grant will be considered closed. This may occur before the June 15, 2017 deadline.

Approved applicants will be notified that their event has been approved. Funding will be released when the Follow-up Form and event receipts are submitted to SPRA.

7. **Eligible Expenses**

Includes promotional materials, entertainment or the purchase of JRPM promotional items. Examples of eligible expenses (but not limited to):

- Posters JRPM promotional Entertainment costs items
- Decorations Tent rental Pins
- Sound equipment rental _

8. **Ineligible Expenses**

Examples of ineligible expenses (but not limited to):

- Capital expenditures Cash prizes Out-of-province travel
- Alcoholic beverages Food expenditures **Payroll expenses**
