



1. Introduction

Recreation and parks opportunities are essential to the wellbeing of Saskatchewan's residents and communities. The Saskatchewan Parks and Recreation Association (SPRA)'s *June is Recreation & Parks Month (JRPM) Celebration Initiative Grant* provides a foundation from which to launch activities that increase awareness of the benefits of participation in recreational activities and to promote access to parks and open spaces. Increasing civic participation is one of the best ways to reduce health care costs and enhance social cohesion. Involvement and participation in recreation contributes to the development and maintenance of social, emotional and physical well-being for individuals living in your community.

The JRPM Celebration Initiative Grant is specific to the Recreation Section of the Saskatchewan Lotteries Trust Fund for Sport, Culture and Recreation. It is managed and administered by the Saskatchewan Parks and Recreation Association (SPRA).

The amount of funding available for *JRPM Celebration Initiative* projects depends upon the availability of Lottery Funds in the Recreation Section for that specific year.

2. Purpose

SPRA would like to acknowledge the continued impact that the *JRPM Celebration Initiative Grant* has on the recreation and parks services in Saskatchewan. In 2019, our organization is pleased to have the opportunity to offer financial assistance to JRPM Ambassadors, through supporting communities and agencies that are **Active members** of SPRA. Through this funding program, we are able to:

- Support localized promotion of the sector's benefits
- Ensure that June will be recognized as "Recreation & Parks Month"
- Support planned events or programs

3. Eligibility

- Active members of SPRA are eligible to apply
- Communities that are registered as a JRPM Ambassador and conduct an event that runs between June 1 to June 30, 2019 are eligible to apply
- Communities that have outstanding follow-up reports for other SPRA grants are not eligible to apply

The JRPM Celebration Initiative Grant is available to eligible Active members of SPRA.

Eligible **Active members** include Cities, Towns, Villages, Rural Municipalities, First Nation Communities, Provincial Recreation Associations, Sport, Culture and Recreation Districts, Tribal Councils, Métis Regions and Regional/Urban Park Authorities. SPRA membership must be current prior to approval of a submitted application.

Note: The contact name on the application must match the contact name on the SPRA membership.

4. Available Assistance

SPRA Active members that are registered in the JRPM Ambassador Program, and plan to deliver a community wide event, can apply for this funding. SPRA will contribute a maximum of \$500 per Active member. Only one grant per Active member will be processed. As per all SPRA grants, funding for retroactive expenses will not be approved.

Examples of Eligible Expenses

The following are examples of eligible expenses, including, but not limited to, promotional materials, entertainment costs or other supplies:

Posters

Entertainment costs

Tent rental

- Decorations
- Sound equipment rental
- Pins

5. Ineligible Expenditures

Criteria established by the Saskatchewan Lotteries Trust Fund are to be followed when creating the expense plan. The following areas are not eligible for support from Lottery Funding:

- Capital expenditures, assistance for the construction, renovation or repair of capital facility projects such as arenas, pools, parks, athletic fields, trails, buildings, grounds, etc.
- There will be no duplication of funding for opportunities currently funded through the Saskatchewan Lotteries Trust Fund
- Food related expenditures food expenses for banquets, dinners, fundraising and celebrations
- Subsidization of wages for employees
- Property taxes, insurance
- Alcoholic beverages
- Cash prizes
- Uniforms, or other personal items

6. Application Process

Applications will be accepted from May 9, 2019 to June 15, 2019. Applications received, within the eligibility criteria, will be adjudicated based on a first come, first served basis. The *JRPM Celebration Initiative Grant* funding is capped and once the funds are allocated, the Grant will be considered closed. This may occur before the **June 15, 2019** deadline.

Applicants will be notified if their event has been approved. Funding decisions are final and will not be revisited, or be subject to appeal.

Projects will not be funded retroactively. Any project beginning prior to the application deadline will not be considered. One hundred percent (100%) of the total amount granted to a project will be sent to the organization upon receipt and acceptance of the completed Follow-up Form, with copies of the event receipts.





7. Funding Obligations

All funds must be used by June 30, 2019. Follow-up materials must be submitted by Monday, August 12, 2019.

Where possible, groups receiving grants must publicly acknowledge Saskatchewan Lotteries and the Saskatchewan Parks and Recreation Association within their events. Funds granted through the *JRPM Celebration Initiative Grant* may only be used for the purpose stated in the application. Funds are non-transferable. SPRA must approve, in writing, any significant change in the use of funds. **Funds used for ineligible expenses will not be reimbursed by SPRA.**

Grants will not be approved if an applicant has any outstanding grant follow-ups with the Saskatchewan Lotteries Community Grant Program, SPRA or the Saskatchewan Lotteries Trust Fund.

Failure to meet the funding obligations to the satisfaction of SPRA will be grounds to withhold payment and restrict access to future funding.

8. Follow-up Requirements

Successful applicants will be required to submit a follow-up report before August 12, 2019. Follow-up Forms will be forwarded to successful applicants. Applicants that do not complete this Follow-up Form will not be reimbursed for their event.

In addition to the completed Follow-up Form, SPRA requires the following financial accountability for the complete grant amount: photocopies of actual receipts, payroll records/cancelled cheques or a schedule from the audited financial statement of the organization that verifies project expenditures.

SPRA would like to showcase the impact that this funding has had in your community. In order for SPRA to demonstrate how your community has benefited from this funding, please send us pictures, videos and written testimonials. SPRA is more likely to use your photos and videos when a release form has been signed by the participants or their legal representative. If the community does not have an established release form, SPRA's Release Form can be used and the completed forms can be submitted with your Follow-up Form.
