Joint Use Agreements

Fast Facts

- A Joint Use Agreement is a formal agreement between a school district or school, and a municipality or community group who want to share use of a facility.
- School facilities and grounds are integral parts of public infrastructure that provide children and youth with spaces for learning, socializing and exercise.
- Once the school day is over, many school grounds and facilities sit empty, especially in Elementary schools.
- A recent National Survey on Joint Use Agreements showed that only 3% of partners are engaged in Joint Use Agreements¹

What are the Benefits?

For Schools

- Create and support recreational opportunities for students and at-risk youth during the after school time period.
- Improve connections with your community through recreation and after-school activities.

For the Community

- Create more recreation opportunities for children and youth.
- Increase the options for community programs with additional facility space.
- Build stronger relationships with school partners.

How to Establish a Joint Use Agreement

Use this Checklist for your Agreement:

Program Provider

- Establish what space and equipment is required for your program
- Determine the dates, times and capacity of the program
- Obtain liability insurance or partner with the school to use theirs
- Ensure your staff is trained in HIGH FIVE® or have received relevant training
- Carry out a risk assessment of the space

School District or Facility

- Notify community of willingness to share facility space
- Consider insurance to support recreation and after school programs in your school
- Determine operational procedures for scheduling, maintenance and staffing
- Train program staff in HIGH FIVE®
- Consider waiving facility fees

General Terms of an Agreement

- Determine fees (if applicable)
- Provide procedures for any loss, damage and liability
- Agree on insurance requirements
- Establish an internal policy for use of facility space
- Sign and agree to Terms and Conditions
- Outline a Cancellation Policy
