



#### Minutes of the

Annual General Meeting of the Saskatchewan Parks and Recreation Association (SPRA) GoToWebinar Platform Tuesday, October 24, 2023 at 1 p.m.

### 1. Call to Order

Jody Boulet, President, welcomed everyone to the 2023 SPRA Annual General Meeting (AGM).

Jody acknowledged the special guests from the Ministry of Parks, Culture and Sport – The Honourable Minister Laura Ross and Tracy Morey, Executive Director of the Sport, Culture and Recreation Branch, and from SPRA's Lottery Partners – Curtis Markewich, Sask Sport Administration Manager and Dean Kush, SaskCulture CEO. Jody also welcomed the 2022-2023 SPRA Board of Directors and past Board of Directors.

Jody thanked Murray Hidlebaugh, past President, for filling the role of Parliamentarian again this year.

Jody called the meeting to order at 1:04 p.m.

Jody referred to and read the following land acknowledgement:

The Saskatchewan Parks and Recreation Association would like to acknowledge that our programs, services and support reach lands covered by Treaties 2, 4, 5, 6, 8 and 10, the Traditional Territories of the Cree, Dakota, Dene, Lakota, Nakota and Saulteaux peoples, and homeland of the Métis.

The land we call Saskatchewan has been part of the lives of Indigenous peoples long before our organization existed and continues to be now and into the future. We are grateful to those who have called this ancestral land home for generations, and whose histories, languages and cultures continue to influence our communities.

We respect and honour the Treaties, reaffirm our relationships with one another, and move forward together in the spirit of truth, reconciliation and collaboration.

We are all Treaty people.

He thanked the Government of Saskatchewan for their continued support for the sport, culture and recreation sector in the province through the signing of the Lottery License Agreement. Through this agreement, proceeds from Sask Lotteries are dedicated to sport, culture and recreation organizations to benefit communities throughout the province.

**6.** Adoption of Auditor's Report and the June 2023 Audited Financial Statements
Jody called upon Mark Sather, Finance and Administration Manager, to deliver the 20222034 Financial Report to the membership.

KPMG reported a clean audit report for the 2022-2023 fiscal year. This was the sixth year KPMG conducted an audit for SPRA and the organization continues to be satisfied with KPMG's performance.

Mark highlighted that assets increased by \$242,000 from last year, mainly in the Unrestricted Fund Investments line. This increase was a result of the surplus and a decrease in liability. Current liabilities decreased by \$86,000 compared to the prior year, this is mainly in the Grants Payable to Funders line. The General fund increased by \$328,000, which matches the surplus on the Statement of Operations. Restricted Net Assets were unchanged.

On the Statement of Operations, under our Saskatchewan Lotteries Trust Fund Grant, there is an increase of \$212,000 for Program Initiatives. For Self-generated interest revenues are up \$170,000 and this is mainly due to the increases in the Bank of Canada interest rates.

Program services expenses were up primarily due to an increase in grants out to members and communities. Program Initiatives are balanced with our Program Initiatives funding with the Saskatchewan Lotteries Trust Fund.

The 2022-2023 net surplus of \$328,000 was added to the General Reserve Fund and was achieved as increase in non-lotteries revenues and savings in labour expenses.
